# **Application and use**

### SURFACE PREPARATION

<u>New wood or renewed</u>: the support must be perfectly dry, the humidity of the wood must not be over 18%. All the surfaces to paint must be cleaned, dry and free from any trace of contaminants. Sand down with P80-P120 sanding paper. Before proceeding with the application of the provided products, blow using dry and clean air, in order to remove every trace of sanding and dirt. Apply the first coat of SUNGLOSS diluted 10 - 15%. Proceed with the following coats (3-5 coats) as well as explained. <u>Painted wood :</u> sand down in order to eliminate every varnish trace during the stripping vessel phase; apply the first coats of SUNGLOSS, diluted 5% than proceed with the following coats (2-4 coats) as before.

N.B: Between the coats, use abrasive Scotch Brite fine (grey).

**N.B.** <u>The drying times and the overcoating intervals increase with higher thickness of the applied film</u> Always check that the existing painting film is perfectly dry before applying a further product coat.

## **CONDITIONS DURING APPLICATION**

In order to avoid the formation of condensation, the temperature of the surface should be at least 3 °C above dew point. During the application and curing the min. ambient temperature must not be lower than 15°C or higher than 30 °C and the minimum temperature of the support must not be lower than 10°C , because the crosslinking is significantly slowed at temperatures below. Application is not advisable when relative humidity exceeds 80%. The term-hygrometric survey should be carried out near the surface to be coated. Make sure there is enough ventilation when the application takes place in closed areas

## Storage

It is recommended to avoid exposure to air and extreme temperatures. To maximize the shelf life in the can, it is good to check that the container is well closed during the storage and the temperature is between 10 °C and 35 °C. Avoid exposure to direct sunlight.

# Safety rule

Observe the provisions of DPR 303 and 547. Avoid contact with the skin, for example. Operate in well ventilated places and, if in closed areas, use vacuum cleaners, fans and air conveyors. During the application use appropriate protections (masks, gloves, glasses, etc.). Before using, read sections 7-8 of the SDS.

INSTRUCTIONS FOR THE DISPOSAL OF PRODUCTS AND PACKAGING

Empty packaging that contained products: Dispose of empty packaging according to the requirements of the waste disposal law, for example by taking them to the recycling center.

Packages containing the unused products: Dispose of the unused product in accordance with the law of disposal of such waste, for example by taking it to a recycling center, recycling of packaging is prohibited in this case. Do not empty into drains or watercourses. Product packaging must be kept indoor, and the temperature in the storage place must be between 10 °C and 35 °C. Do not expose to sunlight.
